Craig- Pretty much agree with the discussions. We need to allocate some land to the harbor. Babic- Been thinking that we want to figure out a way to work with council to get us some type of guarantee for our land. Betts- Agree with Max. Look into the basin by Copper River for expansion. I would like to fill in by the shipyard by we will need to rewrite an RFP to make it lucrative for people to bid on it.
