Harbormaster's Report: The report was printed in the agenda packet. Harris is scheduled to arrive Monday to fix ocean dock. Wiese asked if any other department was burning used oil, response was that the Harbor will be shipping oil out this year to dispose of it. The Harbor assessment can move forward without and RFP as long as there are at least three quotes for service.

Harbormaster's Report

- Used oil ISO tanks arrived and we should have 12,000 gals of used oil ready to be shipped out next week
- Replaced torn out electrical pedestal on C-float
- Installed new light pole and LED light on D-float
- USCG MSO Valdez conducted the facility security inspection. All Sat
- AKOSH conducted a safety inspection of the harbor facilities
- Attended the USCG FRC placement selection meeting
- Met with the acting CM about ideas about fees for the vessel Polar Bear to remain on city tidelands
- Reconnected 5 finger floats
- Sent eviction notices to 7 vessels that did not meet harbor regulations. 2 vessels were crushed, one towed to marina, one went to Shipyard for repairs, one made repairs in the harbor. Still awaiting two others to be removed
- Removed window in hallway of office and closed up
- Replaced all restroom lights with LED lights
- Sold 6 impounded gill nets
- Replaced 70 feet of bull rail
- Cut, painted and installed slip name tags
- Worked with NVE to complete and submit TIGER grant for the replacement of G-float
- Organized and numbered spaces in storage lots
- Towed 3 vessels
- Conducted 131 vessel lifts at the Shipyard so far this year
- Issued 6 parking tickets

Passenger Fees

Seward:

(a) *Fee.* In addition to other tariff provisions, the terms and conditions of this item apply and charges are assessed to passenger vessels, sport fishing vessels, guide and outfitter vessels, and all other vessels carrying passengers for compensation. A passenger fee of \$3.50 per passenger shall be paid for each passenger embarking or disembarking a vessel at a City Dock, as such term is defined in Subsection 100 hereof. The passenger fee is assessed once per passenger per excursion regardless of whether the passenger excursion is one-way or round-trip. As used in this subsection, "compensation" means payment to the vessel owner or operator whether by charter or through fares paid by or on behalf of passengers.
