Special Meeting – 2015 Budget

- F. REPORTS: 2015 Budget:

Herschleb states that we will talk about the two capital projects first.

- Filter Tank: Herschleb states that she will start with the pool capital project, building a stainless steel filter tank with PVC piping. Herschleb starts by explaining how this capital project has come about. The quote for this job is 32.5K. Chester pool wrote us and offered to throw in a new set of filter assemblies for free, re-do the tank, charge zero interest and let us pay ½ this year and the other half the following year.
- Waste oil Burner: Herschleb said that the other capital project is a waste oil burner for Bidarki. Herschleb states that we believe it will be about 4 hrs. Per week of maintenance, we would have the regular system run tandem as back up. It will kick on at any time to offer continuity of service to our folks. We would have to get a 17,500 gallon settling tank. Kiwi quoted us \$4000.00 for the plumbing and the electrician \$1200.00, and it would be about \$4200.00 annually for maintenance. Kiwi believes it would be a 5-8 year payback. He also believes it will be a \$7,000.00 -\$10,000.00 savings in heating fuel per year. M. Dunbar asks where we would get the oil from. Herschleb replies we would get it directly from the harbor.
- **Budget: Herschleb** said that we added 10k onto Pool Repair and Maintenance, if the capital project was not accepted. But as far as Bidarki is concerned it is a flat budget.
- Parks Maintenance: Herschleb states that there are no changes there.
- **Herschleb** states that Odiak Camper Park is an enterprise fund. We as a group just reviewed the master plan last year and we have some current projects listed in priority.

Additional RV parking is discussed.

Herschleb states there is no quorum but we can get a concurrence of the Parks and Rec. Commission to approve the budget packet as presented.
