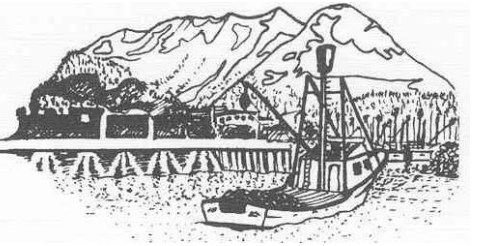

**Call to order:** This meeting was called to order by Jake Betts @ 6:00 pm.

**Communications by Visitors:** Katrina Hoffman: Just here to answer any questions about the Sea Grant lease if needed, and thanks for the dock replanking.

**Harbormaster's Report:** The report was printed in the agenda packet. Additional: We were selected for the Tier 1 grant if it gets funded next year. We should know about the Build Grant in December.

**New Business:**

- A. Sea Grant building lease: Council would like to hear Harbor Commissions opinion on if we should continue to lease this building to the Prince William Sound Science Center. Schinella: The Science Center has done substantial work to the building so that it would continue to meet their needs. The harbor does not have a conflict with the Science Center continuing with the lease. Craig: Would recommend continuing to lease the building to the Science Center on a short term basis while they are building new facilities. General discussion and the Harbor commission was of the consensus that they would like to see the Science Center retain the lease on a short term basis.

**Miscellaneous Business:** Comments for next meeting topics? Betts: Would like to see information on the revenue generated from last year's wharfage and fish tax changes. Jones: Maybe a discussion on what will happen to the airplane float when the harbor is repaired. Can we get a camera system update?

Progress on building was on hold, but the grant agreement has been signed and the funds have been released. There are RFPs for design being released, and job openings being announced.
