RE: CARES ACT FUNDING

COUNCIL ACTION: Ratification of CARES Fund allocations and approval of COVID projects funded with CARES Funds.

City of Cordova has been awarded \$3.414M to spend on COVID related projects and economic recovery. Staff recommends allocating the funds in five categories as outlined below. The CARES resources are federal dollars disbursed through the State of Alaska and must be expended by December 31, 2020 in accordance with federal CARES rules.

\$900,000 – First Responder and Incident Management Team Payroll.

This allocation includes a reimbursement of City payroll expenses for Incident Management Team, Fire Department, Police Department, Public Safety Dispatch for the duration of the public health emergency.

\$250,000 – CARES Act Administration & Non-Payroll Expenditures.

This allocation covers City contractual and other administrative expenses incurred to develop, implement and communicate mandates and rules necessary to ensure the health and safety of City employees and residents.

\$1,189,908– Facility Enhancements

This allocation includes purchases and project to ensure the health and safety of City employees and residents thorough COVID19 recommended improvements.

The attachment that follows outlines specific projects suggested by staff and Council that meet the intent of CARES dollars and can be accomplished this calendar year. Council will be asked to review and select projects that will be funded with Cordova’s CARES award.

\$75,000 – Non-Profit Grants

Direct investment in the Cordova Community Foundation to provide support for community programs and services provided by local non-profit organizations.

\$1,000,000– Individual Assistance Grants.

Staff recommends a “bottom up” approach to our local economic recovery by distributing CARES funds directly to individuals for expenditure at local businesses. The City will develop a program and determine eligibility restrictions and requirements which will be brought to Council in the form of a resolution for consideration.

I. REQUEST OR ISSUE: Direction to staff.

II. RECOMMENDED ACTION / NEXT STEP: Council discussion of merits to the options listed below and/or alternatives.

III. FISCAL IMPACTS: Specifics as yet to be determined by City Clerk, more work to be done to assess cost differential of the various approaches. Currently City Election line item is budgeted at \$2,000 for 2020. Actual in 2019 was \$1,401, in 2017 was \$6,359 (there was a general election in March and a Special Election in November that year). If mailed ballots are to be by first class mail 2,000 ballots could be \$1,000 to mail. Currently mailed ballots are sent certified at \$8 each.

IV. BACKGROUND INFORMATION: The COVID-19 emergency is the impetus of this discussion/consideration as the safety of election day gatherings in small locations to vote is being pondered across the country. Cordova's Election Board is composed of mostly retired individuals who may be deemed higher risk for complications with COVID-19. That may cause problems in securing a board each year (usually 5 elections clerks are hired for an election). Other protective measures and protocols will need to be employed in the polling place to protect the voters entering to vote (screens/ lines to allow only a small number in the room at a time/ each voter gets his own pen/ fewer booths set up/ cleaning supplies/ etc.). Such measures will be employed whether we switch to a hybrid election or maintain status quo.

Secondarily, proponents of all-mail elections across the country are touting the probability of increased voter turnout in an all-mail election system. Obviously, increased voter turnout is always encouraged and actions to aid voter turnout would be beneficial.

To get ahead of our March 2021 next Regular Election, the Clerk needs direction from City Council as to what if any avenue toward change she is to pursue.

V. LEGAL ISSUES: City Code Title 2-Elections can be read and reviewed here https://library.municode.com/ak/cordova/codes/code_of_ordinances?nodeId=TIT2EL . Code amendments and or a complete rewrite of Title 2 can be undertaken by staff and will require legal assistance/review.

VI. SUMMARY AND ALTERNATIVES: Council should discuss the issue and come to a consensus to direct staff:

- 1) to maintain status quo with City Elections – make no Code changes;
- 2) wait and see how State August primary and General Election in November go;
- 3) make adjustments to City Code to allow more ease in voting by mail, possibly to include easier early voting options;
- 4) re write Code entirely to go to Election 100% by mail for Cordova Local Elections;
- 5) Council alternative option concerning City Election Code
