Re: Request for Operating Funds

CCMC continues to have issues with delayed payments from 3rd parties. This is due to a combination of working through issues with the new Electronic Health Record (EHR) and the way Medicare/Medicaid has been delaying payments.

In addition, CCMC has about \$400,000 remaining to pay Healthland for the EHR software and Tekmate for the new hardware to support the EHR. CCMC has a payment plan with both companies. We pay Healthland \$50,000 per month and Tekmate \$25,000 per month. This will be paid off in February/March 2016.

Requested Motion: I move to approve Resolution 09-15-40 requesting a transfer of \$350,000 from the General Fund Reserve to Cordova Community Medical Center.
