SUBJECT: Substitute Ordinance 1137

Mayor Kacsh has researched other Codes and decided to mimic the Bethel Municipal Code in this, his proposed ordinance adopting City Code regarding the use of non-biodegradable plastic bags and polystyrene foam disposable food service ware. He asserts that although the Problem Solvers initially suggested a "seasonal" ban, he would prefer it be year round so as not to appear as a punishment to locals (i.e. year round Cordovans) only. Also, his suggestion is to allow a year for businesses and the public to become prepared for the change. Therefore, the ordinance effective date says 30 days after passage and publication or October 1, 2016 whichever is later.

Ordinance 1137 was discussed when it was before the Council at the October 7 Regular Meeting. At that time it was referred to staff so the City Attorney could review the ordinance and also could answer Council's concern regarding enforcement of such a ban if it were to be adopted into City Code. The City Attorney has made a small edit to the ordinance which is why it is now titled "Substitute" Ordinance 1137. She added a definition of "plastic carry-out bag" as she has seen that has given other muni's problems without a good definition of that term. City Attorney Holly Wells will be available for an executive session to discuss the enforcement issue with Council.

Substitute Ordinance was before Council for first reading at the November 4 regular meeting. It was approved 5-0 and is now before Council for public hearing and second reading.

CITY OF CORDOVA, ALASKA SUBSTITUTE ORDINANCE 1137

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORDOVA, ALASKA ADOPTING CORDOVA MUNICIPAL CODE CHAPTER 8.37 GOVERNING THE USE OF NON-BIODEGRADABLE PLASTIC CARRY-OUT BAGS AND POLYSTYRENE FOAM DISPOSABLE FOOD SERVICE WARE IN THE CITY OF CORDOVA

WHEREAS, it is in the best interest of the City of Cordova to limit the littering of the environment with non-biodegradable and environmentally hazardous materials; and

WHEREAS, it would be cost-effective for less of this type of waste to wind up in Cordova's landfill; and

WHEREAS, the Cordova School District's '*Future Problem Solvers*' brought this topic to the attention of the City Council and the group is also interested in pursuing the overall diminished use of plastics in Cordova; and

WHEREAS, this ordinance is flexible in its wording by allowing for some exemptions.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Cordova, Alaska, that:

Section 1. Cordova Municipal Code Chapter 8.37 is adopted to read as follows:

Chapter 8.37 - PLASTIC BAGS AND POLYSTYRENE CONTAINERS

8.37.010 Definitions.

"Affected retail establishment" means any commercial business facility that sells goods directly to the ultimate consumer including but not limited to grocery stores, pharmacies, and retail stores.

"Biodegradable" means the entire product or package will completely break down and return to nature, i.e., decompose into elements found in nature within a reasonably short period of time after customary disposal.

"Customer" means any person obtaining prepared food from a restaurant or retail vendor.

"Disposable food service ware" means all containers, bowls, plates, trays, cartons, cups, lids, and other items that are designated for one-time use and on, or in, which restaurant or retail food vendors directly places or

packages prepared food or which are used to consume foods. This includes, but is not limited to, service ware for takeout foods and/or leftovers from partially consumed meals prepared at restaurants or retail food vendors.

"Food vendor" means any restaurant or retail food vendor located or operating within the city of Cordova.

"Plastic carry-out bag" means a bag made from plastic that is not intended nor suitable for continuous reuse and that is less than 2.25 mils thick and is designed to carry customer purchases from a seller's premises, except for: bags marketed or labeled as "biodegradable" or "compostable," bags used by customers inside stores to package bulk items such as fruit, vegetables, nuts, grains, candy, or small hardware items, such as nails and bolts; bags used to contain dampness or leaks from items such as frozen foods, meat or fish, flowers or potted plants; bags used to protect prepared foods or bakery goods; bags provided by pharmacists to contain prescription drugs; newspaper bags, laundry or dry cleaning bags; or bags sold for consumer use off a seller's premises for such purposes as the collection and disposal of garbage, pet waste, or yard waste.

"Polystyrene foam" means and includes blown polystyrene and expanded and extruded foams which are thermoplastic petrochemical materials utilizing a styrene monomer and processed by any number of techniques including but not limited to fusion of polymer spheres, injection molding, foam molding, and extrusion-blow molding. Polystyrene foam is generally used to make cups, bowls, plates, trays otherwise known as Styrofoam.

8.37.020 Non-biodegradable plastic carry-out bags.

A. Affected retail establishments, food vendors and nonprofit vendors are prohibited from providing plastic carry-out bags to their customers at the point of sale to transport purchased items. Reusable bags, recyclable paper bags and compostable bags, including biodegradable plastic bags, are allowed alternatives.

B. Nothing in this section shall be read to preclude affected retail establishments, food vendors and nonprofit vendors from making recyclable paper bags available to customers.

C. Affected retail establishments, food vendors and nonprofit vendors are encouraged to provide incentives for the use of reusable bags through education and through credits or rebates for customers that use reusable bags at the point of sale for the purpose of carrying away goods.

D. No person shall distribute plastic carry-out bags at any city facility or any event held on city property.

8.37.030 Polystyrene foam disposable food service ware.

A. Except as provided in CMC 8.37.040, food vendors are prohibited from providing prepared food to customers in disposable food service ware that uses polystyrene foam.

B. All city facilities are prohibited from using polystyrene foam disposable food service ware and all city departments and agencies will not purchase or acquire polystyrene foam disposable food service ware for use at city facilities.

C. All food vendors using any disposable food service ware will use biodegradable or compostable disposable food service ware unless they can show an affordable biodegradable or compostable product is not available for a specific application. Food vendors are strongly encouraged to reuse food service ware in place of using disposable food service ware.

8.37.040 Exemptions.

A. Prepared food prepared or packaged outside the city of Cordova is exempt from the provisions of this chapter. Purveyors of food prepared or packaged outside the city of Cordova are encouraged to follow the provision of this chapter.

B. Food vendors will be exempted from the provisions of this chapter for specific items or types of disposable food service ware if the city manager or his/her designee finds that a suitable affordable biodegradable or compostable alternative does not exist and/or that imposing the requirements of this chapter on that item or type of disposable food service ware would cause undue hardship.

C. Polystyrene foam coolers and ice chests that are intended for reuse are exempt from the provisions of this chapter.

D. Disposable food service ware composed entirely of aluminum is exempt from the provisions of this chapter.

E. Emergency Supply and Service Procurement. In a situation deemed by the City Manager to be an emergency, for the immediate preservation of the public peace, health or safety, city facilities, food vendors, contractors and vendors doing business with the city shall be exempt from the provisions of this chapter.

<u>Section 2</u>. This ordinance shall be effective thirty (30) days after its passage and publication or October 1, 2016, whichever date is later. This ordinance shall be enacted in accordance with Section 2.13 of the Charter of the City of Cordova, Alaska, and published within ten (10) days after its passage.

SUBJECT: Ordinance 1138

With the opening of the Cordova Center and the multiple bookings of late, we have seen a glitch in the smooth transition to the fully functioning conference and event venue that the Center will be for the City of Cordova. Council has determined that it is too time intensive to continually bring use permits regarding this Code section to them for approval. Council directed staff to bring forward an ordinance to remedy this glitch. Ordinance 1138 is before the Council tonight and it should do exactly that. The City Manager or his designee will be responsible for the use permit that except's the Cordova Center from the provision in 6.12.030.

This ordinance sees a slight edit from first reading but is not substantial enough to require another first reading. Tonight it is before Council for a public hearing, second reading and final approval.

Required action: Majority roll call vote or approval of the consent calendar on second reading.

CITY OF CORDOVA, ALASKA ORDINANCE 1138

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORDOVA, ALASKA, AMENDING SECTION 6.12.040 OF THE CORDOVA MUNICIPAL CODE REGARDING ISSUANCE OF USE PERMITS FOR ALCOHOLIC BEVERAGES – CONSUMPTION IN PUBLIC PLACES

WHEREAS, the Cordova Center is currently booking events such as conferences, concerts, weddings, etc.; and

WHEREAS, the consumption of alcoholic beverages at such events is customary, expected by the sponsoring entity, and enhances the marketability of the Cordova Center; and

WHEREAS, it has become impractical to have the City Council except by use permit the Cordova Center from the provisions of 6.12.030 each time an event is scheduled.

BE IT ORDAINED by the City Council of the City of Cordova, that:

Section 1. Section 6.12.040 of the Cordova Municipal Code is hereby amended as follows:

6.12.030 - Alcoholic beverages—Consumption in public places.

A. It is unlawful for any person to consume any alcoholic beverage on any public street, alley or highway within the city limits or in or upon the grounds of any city building or property, except as permitted by ordinance, use permit or regulation.

B. It is unlawful for any person to possess any open bottle, can, or other receptacle, containing any alcoholic beverage on any public street, sidewalk or alley within the city limits or in or upon the grounds of any municipal building or property, except as permitted by ordinance, use permit or regulation.

C. The city council is authorized to designate public areas and places within the city limits, in addition to those specified in subsection A and B of this section, in which the consumption of alcoholic beverages or possession of open alcoholic beverage containers is prohibited, and to cause signs to be posted in such areas or places advising members of the public of the prohibition.

6.12.040 - Exceptions.

<u>A.</u> The city council is authorized by use permit to except any public street, alley, highway, city building or city property from Section 6.12.030.

B. The city manager or his designee is authorized by use permit to except special events at the Cordova Center from Section 6.12.030.

Section 2. This ordinance shall be effective thirty (30) days after its passage and publication. This ordinance shall be enacted in accordance with Section 2.13 of the Charter of the City of Cordova, Alaska, and published within ten (10) days after its passage.

CITY OF CORDOVA, ALASKA RESOLUTION 11-15-47

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORDOVA, ALASKA, CALLING ON THE STATE AND FEDERAL GOVERNMENTS TO RECONSIDER THEIR DECISION TO FOREGO RESTORATION FUNDS UNDER THE EXXON VALDEZ SETTLEMENT RE-OPENER CLAUSE

WHEREAS, in 2001, the state and federal governments settled civil claims regarding the *Exxon Valdez* Oil Spill, and the settlement included a so-called "re-opener" clause allowing the governments to pursue up to \$100 million in additional funds for damages unanticipated at the time of the settlement; and

WHEREAS, in 2006, the state and federal governments filed a demand letter with Exxon calling for \$92 million to implement a restoration plan designed to recover sea otters and sea ducks in the spill affected area; and

WHEREAS, Exxon refused to act on the demand letter, and in the ensuing years, otters and sea ducks recovered to pre-spill levels; however, herring did not recover, and to this day, *Exxon Valdez* oil remains embedded in Prince William Sound beaches; and

WHEREAS, the federal district court in Anchorage issued an order on April 17, 2015, calling for the opportunity for public comment prior to the disposition of the re-opener claim; and

WHEREAS, on October 4, 2015, the state and federal governments moved to close all re-opener claims, and failed to provide the public an opportunity to comment on the re-opener claim; and

WHEREAS, the U.S. Government also failed to uphold its obligation to engage in governmentto-government consultation with Alaskan Native Tribes prior to resolving the re-opener claim; and

WHEREAS, the lack of opportunity to comment for the public, spill affected communities, and Tribes is a violation of the public trust; and

WHEREAS, the state and federal governments failed to consider resources and resource services that remain unrecovered due to the 1989 Exxon Valdez Oil Spill, including but not limited to Pacific herring and residual oil in intertidal sediments; and

WHEREAS, the injuries unfolding today in the spill affected area were clearly unanticipated in 1991, they are substantial, and there are cost-efficient restoration options for mitigate these harms; and

WHEREAS, the October 14, 2015 Status Report and decision ignored a broad range of government research conducted since the 2006 that prove ongoing harms that were unanticipated in 1991; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cordova, Alaska does hereby ask that:

1. The state and federal government immediately vacate their decision to close claims related to the re-opener clause; and

- 2. The 2006 re-opener filings be amended/augmented with updated scientific information on the lack of ecological recovery; and
- 3. The governments hold public hearings to hear from Alaskan citizens on the issue; and
- 4. The federal government engage in government to government consultation with Tribes in the spill affected region; and

The governments file a claim in court against Exxon for the full \$92 million plus interest that was made claim to in 2006.

The Alaska Historical Commission serves as the geographic names board for the State of Alaska. The citizen's board, chaired by the Lt. Governor, reviews names proposed for lakes, streams, mountains, and other physical features in the state. The commission coordinates its program with the U.S. Board on Geographic Names. The commission has developed a process to consider proposals, as has the federal board. It takes at least a year to name a geographic feature.

To propose an official name for a geographic feature, the first step is to complete and submit an application. GUIDELINES

The Alaska Historical Commission has established the following guidelines which it uses along with the policies of the U.S. Board on Geographic Names (Principles, Policies, and Procedures for Domestic Geographic Names). All proposals must identify the type of proposed name from the categories below and address all of the considerations requested.

Local usage

Local usage is the single, best reason to name a geographic feature. Local usage refers to a name for a geographic feature that has evolved over a period of years, is called that name by the community or area as a whole, and is supported by local petitions, oral histories, documents, or other publications. A feature named by the applicant is not considered local usage, even when the applicant has called the feature by that name for a number of years.

The Alaska Historical Commission will consider a proposal if:

the application includes published evidence of verbal or written usage of the name, petitions signed by local residents, and resolutions or letters of support from government entities and community groups

Descriptive names (includes features named by applicant)

The Alaska Historical Commission will consider if:

- . the name is relevant and descriptive of the feature
- . the name is not in use elsewhere in the region
- . the name is in good taste and not frivolous

the name has been used for a minimum of five years and evidence of the use

is provided

Commemorative names (please read the special section)

The Alaska Historical Commission will consider if:

- . the individual has been deceased for five (5) years and evidence of this is provided
- . the individual made a significant, acknowledged contribution over time to Alaska
- . the individual had a direct, long term association with the feature
- . evidence of local support by authorities and residents is provided

Historical names

The Alaska Historical Commission will consider if:

- . the authenticity of the name can be established
- . the name is clearly associated with the area

Native American names

The Alaska Historical Commission will consider if:

- . the name is in common local use and that use is documented
- the name is linguistically appropriate to the area in which it is to be applied
- . the land owner, if on Native land, supports the proposed name in writing

Name changes

The Alaska Historical Commission will consider if:

the current official name is derogatory to a racial, ethnic, gender, or religious

- group
- the current official name is duplicative and causing confusion
- evidence of extensive local support by authorities and residents is provided

Other

The Alaska Historical Commission will consider if:

there is an overriding need to name a feature within a wilderness area (for

purposes of safety, education, or area administration), and the land manager has

been consulted and given the opportunity to comment on the proposed name

. an existing name is applied to a **related feature**, *i.e.* the name of a mountain is

applied to an unnamed glacier that is part of it

- . the name can be **pronounced** without considerable difficulty
- . a spelling that includes **diacritical marks** (special marks not normally found in the English language) has substantial evidence of active local use, such as official records, maps, and signs, in the area where the feature is located

All proposals must be accompanied by a U.S. Geological Survey 1:63,360 or 1:25,000 scale topographical map with the feature to be named clearly identified on the map. The applicant must explain why the feature should be named. Photographs and other identifying aids are useful, but are not required. Evidence of local support, in the form of letters, petitions, and newspaper articles and letters to the editor, showing public awareness and endorsement of the proposed name is encouraged.

The U.S. Board on Geographic Names has a policy to identify a single official name and spelling for each geographic feature. The board may identify a **variant** name if needed for clarity or reference. A variant is any current or historic name or spelling for a geographic feature other than the official name. It may be in parentheses following the approved name.

COMMEMORATIVE NAMES

A commemorative name of a geographic feature is to honor and recognize an individual who has made an outstanding or noteworthy contribution to an area or the state, or is a national or international figure. A commemorative place name is not intended to memorialize a family member or friend.

Proposals containing a given name (first or last) or nickname of an individual are considered commemorative. The full name of a person as part of a geographic name normally is not approved unless surname use alone would be ambiguous.

The person must have been deceased *for at least five (5) years* before the Alaska Historical Commission will consider the proposal. An obituary and biography of the individual must be part of the proposal.

The person should have a *direct association* with the feature, or have made a *significant contribution* to the area in which it is located.

Direct association. The individual should have been physically present at, or in the vicinity of, the feature for several years; engaged in some activity that affected the feature; or spent a great deal of time at or in the vicinity of the feature. A person's death on or at a feature, such as a mountaineering accident or plane crash, or the mere ownership of land or the feature, does not normally meet this criterion. Recreational use of or visits to a feature does not normally meet this criterion.

Significant contribution. The contribution that the individual has made must be notable, of consequence, and have had an impact on the community, region or state. A significant contribution is an extraordinary effort, achievement, or impact. It may come from the individual's work, professional or civic activities, and can be in the social, political, economic, scientific, or cultural areas. The significant contribution should have benefitted Alaskans beyond the individual's immediate circle of family and friends. Generally, these individuals will have been recognized through a letter of thanks from the Governor, certificates of appreciation from an agency or group, awards, newspaper articles featuring the contribution made, dedication of local man-made features (park, street, garden, building), inclusion in *Who's Who*, etc. The individual might be a historical figure.

Features can be named for persons who made a significant contribution nationally or internationally, especially if the contribution was exceptional and unique. In such instances, the requirement of direct association does not need to be met, but the other requirements for commemorative names must be met.

Commemorative name proposals must include evidence of local support by authorities and residents attesting to the individual's association with the feature and significant contribution.

GEOGRAPHIC NAMING PROCESS

Upon receipt of a proposal, staff review it for completeness and, if necessary, request additional information from the applicant. Of particular concern is that adjacent land owners know of the proposal and agree with the proposed name.

Staff prepare a Domestic Geographic Name Report (a U.S. Board on Geographic Names form) and send it with a map and supporting information to relevant Native groups, public land managers, local governments, and other interested parties for comment. For Native names, the Alaska Native Language Center at the University of Alaska Fairbanks is consulted. Interested parties might include local historical organizations, pilot associations, and outdoor groups.

The Alaska Historical Commission reviews the proposal and all public comments received and takes formal action to approve or not approve a proposed name. The commission is designated the geographic names board

for the state (Alaska Statute 41.35.350). The commission meets at least two times a year. Commission members reference these guidelines in their formal action. The applicant is notified of the meeting at which the commission will consider their proposed name. Every meeting has a public comment period when an applicant can address commission members. Place names approved by the Alaska Historical Commission are official for the State of Alaska and entered into a database.

Following the meeting, applicants are notified in writing of the Alaska Historical Commission's action on their proposal. The proposal, all comments received, and record of the commission's action are sent to the U.S. Board on Geographic Names. Staff there also have a review process before the board considers and votes on a proposed name. The USBGN is the final word on choice, spelling, and official use of the place names in the U.S. Its approval makes a name official nationally. This does not guarantee the name will appear on USGS and other federal maps. When a federal map is revised and updated, efforts are made to add the name. The name is entered in the Geographic Name Information System (GNIS), http://geonames.usgs.gov/domestic/.

The Alaska Office of History & Archaeology has a program manager for geographic names who can be contacted with questions or for additional information.

The proposal is to name a peak for Carl Brady, a prominent Alaska aviator, remarkable pilot and active citizen. The mountain selected is in the same range as mountains named for famous aviators. Billy Mitchell and Jimmy Doolittle. The proposer wants the name to be Mount Carl Brady, similar to the two just mentioned, and notes there was an early Alaska governor named John Green Brady (there is a Brady Glacier and Brady Island, both in Southeast Alaska, named for him) that could cause confusion. Carl Franklin Brady died August 2005 at age 85. He brought the first helicopter to Alaska in 1948 when he was aerial mapping the northern half of Chichigof Island in Southeast Alaska for the U.S. Topographic Survey. Later he founded Era Aviation. He moved to Alaska permanently in 1961. Brady flew over this mountain range for over fifty years, and his companies still serve the region. He was active in public service, serving in the Alaska House of Representatives and Senate in the 1960s, on the Alaska Permanent Fund board of directors, and on a host of civic boards. He was a presidential appointment to the National Advisory Commission on Oceans and Atmosphere and was honorary consul for the Belgian government in Alaska. The proposer hopes the name will inspire youth to pursue science, technology, engineering, and math.







Re: Lease to Alaska State Troopers

Dear Council Members:

I am the owner of Wilson Enterprises, LLC, which has, for over 30 years, leased office space to the Alaska State Troopers, in downtown Cordova. We have been looking forward to and have expected many further extensions of this year-to-year lease. To my knowledge, the tenant Troopers have been quite satisfied with our long term lease relationship. I am contacting you because I recently learned that the City of Cordova may be seeking to have the Troopers move out of my building into space to be provided by the City in Old City Hall.

I have resided and have engaged in numerous business activities in Cordova for many years, and in my experience, the City has always followed a policy of not competing directly with private enterprises in matters outside the City's own proprietary functions: A lease of City property to the Troopers would run contrary to that policy, and would adversely affect our business investment.

We have provided a beneficial lease to the Troopers. Our lease is based upon 1,600 square feet of building space, but the building actually covers 3,000 square feet, most of which is used by the Troopers. Approximately seven years ago, we spent \$15,000 adding a steel and Kevlar bullet-proof front wall to the premises, including a large glass panel and talk-through portal, in order to comply with the Troopers' lease requirements; there was no accompanying increase rental rate.

I am aware that leases of City property may ordinarily be done only through competitive bids or proposals, but that the City may negotiate an agreement with a party who has submitted a letter of interest in leasing; I do not know whether that has occurred.

In any case, I hope you will agree with me that it is not appropriate in a small city like Cordova to discourage local business investment and activity by creating fear that the City may later decide to directly compete with private commerce. I request that the City identify some other useful purpose for the Old City Hall space.

To the Esteemed Mayor,

With the completion of the Cordova Center on the horizon, the Cordova Public Library will be undergoing major changes, both functionally and aesthetically. With this in mind, I feel that it's an exciting time to become more involved supporting a local resource that such a wide range of our community members utilize. I would like to be considered as a candidate to fill one of the board seats.

As a seasoned nomad, moving first between fishing seasons, then academic calendars, and most recently to active duty spouse, libraries across the West coast and the Midwest have provided a haven for me. As a child growing up in Kodiak, countless rainy afternoons and evenings were spent among the shelves. During the not-so-lucrative fishing seasons, the library catalogue of movies became my family's Blockbuster Video. And days upon days of my life as an undergraduate and graduate student were spent curled up in armchairs, hunkered over desks in personal-use work cubbies, and in front of computer screens in libraries from Alaska to Oregon to frigid northern Michigan.

Throughout my time as a military spouse, libraries have consistently provided clear pathways into the communities that my husband and I have moved to. Public events, such as book signings, evening presentations, and monthly book club gatherings have offered a way to interact with locals and to learn about our newest community. Libraries have often acted as a comforting space to migrate to during the early months of transition, when homesickness sets in.
