SUBJECT: CCMC funding

Per your discussion at the 18 November Council meeting, attached please find three options to consider. These were constructed Thursday afternoon in session with the undersigned, Mr. Stavig, Dr. Sundby and Mrs. Varnadoe, and formulated based on Council's discussion of multiple courses of action.

**Option 1:** An LOC for \$700k. Very similar to the one in the 18 November packet, but with additional guidance related to how and when each draw can be made and time limitations for the document.

**Option 2:** A Memorandum of Agreement (MOA) between the CCMC and City for a contribution of \$700k. Like the LOC, there are provision outlining the conduct and timing of each draw, and an expiration date for the agreement.

**Option 3**: A Memorandum of Agreement (MOA) between the CCMC and City for a contribution of \$320k. Mrs. Varnadoe projects this amount will financially carry the hospital through the remainder of this fiscal year, with the prospect of Council including CCMC in its annual budgetary process as it did prior to implementation of the Providence contract. Since the city has just initiated its budget efforts for FY16, the timing of Option 3 is advantageous.

Hopefully one of the above or a derivative thereof will fulfill the desire of Council and the needs of the CCMC. Mrs. Bourgeois will be formally publishing and distributing.

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CORDOVA, ALASKA AUTHORIZING A LINE OF CREDIT FROM THE GENERAL FUND RESERVE IN THE AMOUNT OF \$700,000 TO CORDOVA COMMUNITY MEDICAL CENTER IN ORDER TO FUND OPERATIONAL EXPENSES

**WHEREAS**, the City of Cordova (City) and the Cordova Community Medical Center (CCMC) are partners in providing healthcare services in Cordova; and

WHEREAS, CCMC has needs to pay for an existing electronic health records system, information technology upgrades, and other operational expenses; and

WHEREAS, the City has supported CCMC with loans in the past to support these needs; and

**WHEREAS**, the Finance Director of CCMC shall coordinate draws from the requested line of credit with the City Finance Director before funds will be transferred; and

**WHEREAS**, the leadership of the CCMC shall not request a draw of more than \$150k, each draw shall have an associated repayment term of 90 days, and draws shall not be made more often than 60 days apart; and

**WHEREAS**, the leadership of CCMC shall provide the City with visibility of all accounts receivable and payable on demand; and

**WHEREAS**, this line of credit and its associated terms shall expire on 31 December 2016 unless mutually agreed to by the leadership of CCMC and the Cordova City Council.

**NOW, THEREFORE BE IT** Resolved by the City Council of the City of Cordova, Alaska that by this resolution, it authorizes a line of credit from the General Fund Reserve in the amount of \$700,000 for Cordova Community Medical Center in order to fund operational expenses.
