

**CITY OF CORDOVA, ALASKA
ORDINANCE 1065**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORDOVA,
ALASKA, AUTHORIZING THE TRANSFERS OF MONEY FROM THE GENERAL
RESERVE FUND (PERMANENT FUND) TO GOVERNMENTAL CAPITAL
PROJECTS FUNDS, TO PROVIDE A SOURCE OF MONEY FOR THE CAPITAL
PROJECTS EXPENDITURES WHICH WERE APPROPRIATED IN THE
OPERATING BUDGET FOR FISCAL YEAR 2010.**

WHEREAS, the City Council of the City of Cordova, Alaska, has adopted the City Operating Budget and appropriated funds for FY10 for the period of January 1, 2010 to December 31, 2010, and

WHEREAS, the interfund transfers pursuant to this Ordinance are for providing a source of money to pay for the duly adopted Budget Appropriation of the following capital items: New Police Vehicle \$45,000; High Reach Rough Terrain Forklift with man-bucket (Public Works ½ Share) \$12,500; New Pickup for the Streets \$30,000; Parks Shop Electrical \$10,000; Electrical at Odiak Camper Park \$10,000; Purchase of Nettie Hanson Park \$37,400; Adaptive Motion Trainer \$6,918 for Bidarki; and Repair of Ventilation system at Pool \$25,000, for a total transfer to fund #401 of \$176,818.

WHEREAS, this Ordinance provides for an interfund transfer of \$100,000 to the Chip Seal Fund #410.

WHEREAS, this Ordinance provides for an interfund transfer of \$1,500,000 to Cordova Center Fund #426, which was previously committed to the project as City Matching.

NOW, THEREFORE, BE IT ORDAINED THAT the City Council of the City of Cordova, Alaska, hereby approves the interfund transfers of money in the following amounts:

BE IT FURTHER ORDAINED that the City Council of the City of Cordova, Alaska, does hereby authorize the appropriation of \$1,776,818 from the General Reserve Fund into the General Fund Balance for the approved FY2010 Capital expenditures.


