Vessel security, or vessel monitoring, while in the Harbor and/or Port is not the responsibility of City/Harbor employees, officers or agents.

Payment of Fees: I agree to pay harbor charges and fees for any other service which, I or my designee, order or without order, as may be necessary in an emergency, as defined or decided by the City of Cordova, to protect harbor/port facilities and/or my vessel or other vessels form damage. The City will be indemnified by the vessel owner for any damage to any harbor/port facility as a result of the vessel, its passengers or crew.

<u>Moorage Fees:</u> Moorage will paid on a daily, monthly or annual basis and will be **DUE UPON ENTRY** to the Harbor and Port facilities. I understand that failure to pay in advance will automatically create a daily moorage charge, and may result in the impoundment of the vessel. In the event of unpaid fees and/or services, the City of Cordova against the registered owner's vessel described on this application may file a lien.
