Please Read Below Before Signing

Compliance with regulations: I request mooring and harbor privileges at the Cordova Small Boat Harbor for the above described vessel and agree to abide by the posted rules and regulations as established by Title 11 of the Cordova Municipal Code. **Every owner, operator or agent of any vessel or aircraft using the facilities of the Cordova Port & Harbor shall provide proof of insurance.** I expressly consent and authorize the City to move the vessel in the event fees are not paid, ordinances or regulations are violated, or in the event of an emergency as defined or decided by the City of Cordova. I agree to hold the City harmless from any loss or physical damage to my gear and/or loss of use and/or injury to passenger or member of my crew. I hereby consent to a physical inspection of the vessel and its equipment by Harbor employees, officers or agents, in the exercise of duties as outlined in the Cordova Municipal Code, at any time while the vessel is within the boundaries of the Cordova Small Boat Harbor or the Port of Cordova. Vessel security, or vessel monitoring, while in the Harbor and/or Port is not the responsibility of City/Harbor employees, officers or agents.

Payment of Fees: I agree to pay harbor charges and fees for any other service which, I or my designee, order or without order, as may be necessary in an emergency, as defined or decided by the City of Cordova, to protect harbor/port facilities and/or my vessel or other vessels from damage. The City will be indemnified by the vessel owner for any damage to any harbor/port facility as a result of the vessel, its passengers or crew.

Moorage Fees: Moorage will be paid on a daily, monthly or annual basis and will be **DUE UPON ENTRY** to the Harbor and Port facilities. I understand that failure to pay in advance will automatically create a daily moorage charge, and may result in the impoundment of the vessel. In the event of unpaid fees and/or services, the City of Cordova against the registered owner's vessel described on this application may file a lien.
