Healthcare workforce shortages continue to contribute to stress and expense of our operations. Recruitment and retention for positions that require specific licensing and training is particularly difficult. CCMC continues to be aggressive in promoting work life balance and employee satisfaction, we are creative with our employment and staffing arrangements and yet we continue to struggle to maintain our workforce. Turnover continues to be very costly for our facility.

## **Services**

## Clinic

Volumes are at baseline and continue to improve. Specialty clinics continue as previous and area great asset for our community.

## Sound Alternatives

We continue to recruit for a therapist as well as a community case manager. Staff are working hard to maintain services despite the shortages.

## **Rehabilitation**

Our rehab services expansion has gone well. I continue to hear from the community positive feed back regarding the staff and services provided. We are working on advertising to ensure providers, hospitals and community members are aware of the broad range of services we provide. These include vestibular rehabilitation to improve balance, coordination, vertigo and reduce risk of falls as well as orthopedic post-op for all upper and lower extremity joints. In occupational therapy our therapists create programs that are client-centered, focused on education and support while assisting in restoring function across the lifespan. Occupational therapy is also frequently recommended for children who are experiencing developmental delays, sensory processing deficits or school-based concerns. Please help us ensure that community members know our services are available and can choose in person, hands on therapy as opposed to remote tele services that Cordova has historically utilized.

### Administrative:

We have submitted our cost report and expect to have a positive settlement when that is finalized. For our operations, like other departments, the business office thinly staffed. This month we are bidding farewell to our longest CCMC business office employee, Carol Roemhildt, who is retiring! We continue to evaluate business and revenue cycle maximize the hospital's financial security.
