RESOLUTION NO. 2025-01

A RESOLUTION OF THE CCMC HOSPITAL AUTHORITY BOARD TO REPEAL PARTICIPATION AGREEMENT AMENDMENT NO. 2 TO THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM (PERS), AND TO RE-ESTABLISH PARTICIPATION FOR ALL ELIGIBLE PERMANENT FULL-TIME EMPLOYEES, SUBJECT TO SPECIFIED EXCLUSIONS.

WHEREAS, the Cordova Community Medical Center (CCMC) is a participating employer in the State of Alaska Public Employees' Retirement System (PERS) under a Participation Agreement entered into effective July 1, 1975, and made effective with respect to CCMC separately from the City of Cordova on July 1, 1993, and approved by the State on June 30, 1993; and

WHEREAS, on March 1, 2012, Amendment No. 2 to the Participation Agreement was executed, removing the job position of Hospital Administrator from PERS participation effective April 8, 2012; and

WHEREAS, the CCMC Hospital Authority Board finds that the removal of the Hospital Administrator position from PERS does not align with the Center's current personnel goals and recruitment and retention objectives; and

WHEREAS, the Hospital Authority Board seeks to reaffirm its commitment to equitable benefits across all eligible permanent full-time employees, thereby strengthening its ability to recruit and retain qualified personnel;

NOW, THEREFORE, BE IT RESOLVED BY THE CCMC HOSPITAL AUTHORITY BOARD THAT:

1. Repeal of Amendment No. 2:

Amendment No. 2 to the Participation Agreement with the State of Alaska Public Employees' Retirement System (PERS), which removed the Hospital Administrator position from participation effective April 8, 2012, is hereby repealed.

2. Re-enactment of Coverage:

All permanent full-time employees of the Cordova Community Medical Center, defined as employees in positions normally requiring 30 or more hours of work per week, shall participate in PERS.

3. Exclusions:

The following employee classifications shall be excluded from PERS participation in accordance with the designation permitted to Political Subdivisions under PERS regulations:

Temporary employees

- Casual employees
- Vocational education students
- Contract hire employees
- Volunteer workers
