## **Cordova Community Medical Center**

### **CEO Board Report – August 2025**

#### **Survey Readiness & Quality Improvement**

CCMC continues active survey readiness preparation, emphasizing Infection Control and Quality Improvement initiatives, including sterile processing training opportunities and structured quality monitoring.

#### **Recruitment & Retention**

We have completed most of the milestones for our AHHA workforce retention and recruitment grant. We were able to complete staff space upgrades, improve ergonomic equipment, and purchase a vehicle that is available for use by travelers and visitors for none CCMC business use. We hope this will enable travelers to better explore Cordova and consider permanent job placement as well as improve workplace satisfaction. Branding and recruitment campaign is in progress.

#### **Technology & Partnerships**

CCMC submitted a Response for Information (RFI) to the State of Alaska's Rural Health Transformation Project. Our advocacy centers on:

- **Facility Upgrades:** Patient-centered design improvements, modernized interiors, and workflow enhancements.
- **IT Modernization:** New EMR system with improved interoperability, telehealth integration, Medicaid eligibility verification, and enhanced cybersecurity.
- **Regional Partnerships:** Shared-service models, joint purchasing agreements, and workforce collaboration with other rural hospitals and tribal entities.
- **Statewide Medicaid IT Reform:** A modern, real-time eligibility portal to reduce administrative burdens and delays for rural hospitals and patients.

#### **Clinical Services**

- **Emergency & Inpatient Care**

ER volumes remain strong. Acute census averaged 4.7 patients, with swing bed volumes up to 112 patient days. Staffing increases have helped us to increase our swing and inpatient volume safely and while providing quality care.



- **Long-Term Care** continues to have bed availability.

### **Strategic Initiatives**

- **Healthcare Integration**  
Continued dialogue with the Native Village of Eyak (NVE) for potential service alignment and shared resources.
- **Infrastructure & IT Modernization**  
CCMC is strongly advocating for facility modernization, EMR replacement, and statewide Medicaid IT reform to strengthen sustainability for all rural hospitals.
- **Recruitment & Retention Grant**  
Activities progressing, with workplace and transportation improvements complete. Branding campaign completion is pending final invoice.
