<b>CLASSIFICATION:</b>	HOURLY, NOT TO EXCEED 6 MONTHS
<b>PAY RATE:</b>	Laborer/Maintenance I \$18.00 - \$21.00 PER HOUR, DOE Equipment/Operator I \$25.00+ PER HOUR, DOE
<b>HOURS:</b>	VARIES DEPENDS ON NEEDS
<b>BENEFITS:</b>	THIS IS A SEASONAL/ON-CALL, NON-BENEFITTED POSITION
<b>SUPERVISOR:</b>	STREETS SUPERINTENDENT
<b>POSITION SUMMARY:</b>	Assist with street and facility removal of snow.
<b>QUALIFICATIONS:</b>	Valid State of Alaska driver's license. Must be able to meet the physical demands of the position, work independently, and part of a team.
<b>EQUIP/OPERATOR I:</b>	Previous experience operating snow removal equipment is required. Experience with a grader is preferred.

#### DUTIES:

- Shovel and clear snow from walkways, driveways, and other designated areas (Laborer/Maintenance I)
- Operate snow removal equipment, such as plows, snow blowers, and loaders (Equipment/Operator I)
- Respond promptly to snow events and be prepared for on-call work, including evenings and weekends.
- Adhere to all safety protocols to protect yourself and others.

**WORKING CONDITIONS:** All of the work is performed outdoors in cold and challenging weather conditions. Work is physically demanding with periods of exertion. Frequent work on or near equipment that requires adherence to OSHA standards and generally accepted safety precautions. Some work may be on roofs of buildings.

**PHYSICAL DEMANDS:** Work is physically demanding with periods of exertion. Capable of frequently bending, twisting, and kneeling. Must be able to lift items weighing up to seventy (70) pounds.

#### LEGAL REQUIREMENTS:

As a condition of employment, applicant is subject to a background check (criminal history, verification of education/employment history.) Required licenses must remain valid for the duration of employment.

The above listed duties are intended to describe the responsibilities of an employee in general terms and does not necessarily describe all tasks or functions associated with the position.

This is an excellent opportunity for individuals looking to contribute to the community by ensuring safe and clear transportation routes during the winter months.
