FY26 Final Budget Review

This is our sixth budget work session. Council and staff have worked diligently, made difficult choices, and successfully achieved a balanced FY26 budget. Staff appreciates the Council's support throughout what has been the most challenging budget development process I have experienced in my 15 years with the City.

City staff are already developing plans and coordinating closely to determine how to move forward with priority work in FY26 under a significantly reduced operating budget and with personnel reductions. I am truly honored to work alongside staff who remain understanding, committed, and willing to come together to do the best they can with the resources available.

The FY26 budget will be presented for a vote at the regularly scheduled City Council meeting on December 3, 2025. Following tonight's session, the Clerk will begin the required noticing for the Public Hearing required for the budget and fee schedule resolutions approval.

Attached: "budget changes" table, proposed FY26 general fund budget, 5 proposed FY26 enterprise funds budgets, and proposed FY26 fee & rate schedule.

Second Street Upgrades - \$1.5 million match

The final consideration for the FY26 budget sessions is the \$1.5 million grant match for the Second Street Upgrades. This grant was awarded in 2020, and construction is scheduled to begin in FY27, ideally running concurrently with the Whitshed Road project.

The proposed funding plan for the match eliminates the need to draw from the Permanent Fund and minimally impacts the \$3 million (AMLIP) fund. Thereby leaving a balance that will maintain essential cash flow during the city's lowest revenue periods. On November 18, CTC will consider the City's request for additional matching funds at its board meeting. If a contribution is awarded, adjustments to the funding plan can be made.
